Tender Notice for procurement of air weapons and accessories i.e. Air Rifles, Air Pistols, Air pellets rifle, Air pellets pistol and Air rifle shooting jackets

1.1 Notice Inviting Tender (NIT) for procurement of air weapons and accessories i.e. Air Rifles 4.5mm (.177) caliber, Air Pistols 4.5mm (.177) caliber, Air pellets rifle, Air pellets pistol and Air rifle shooting jackets (along with all factory standard accessories and tools) for 10m indoor Shooting Range at the National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad, NACIN Complex, Sector 29, Faridabad, 121008.

1.3 Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. Bidders are advised to follow the instructions provided in the 'Instructions to the bidders for e-submission of the bids online through the Central Public Procurement Portal for e-procurement at <https://eprocure.gov.in/eprocure/app>.

1.4 Bidder who has downloaded the tender from the NACIN website www.nacin.gov.in and/or Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the tender form in any manner.

2.1 Online bids are invited under Two Bid system for procurement of air weapons and accessories i.e. Air Rifles 4.5mm (.177) caliber, Air Pistols 4.5mm (.177) caliber, Air pellets rifle, Air pellets pistol and Air rifle shooting jackets (along with all factory standard accessories and tools) for 10m indoor Shooting Range (as per Annexure-I) at the National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad, NACIN Complex, Sector 29, Faridabad, 121008.

2.2 (A) Eligibility Criteria The bidder must fulfill the following conditions in order to be eligible for technical evaluation of the bid.

- i. The bidder should have proof of supply of air weapons during any of the preceding 3 years (i.e. 2017-18, 2018-19 & 2019-20) to any Government Organizations/PSUs/Academic Institutions /Reputed Organizations .
- ii. The bidder should have PAN (Permanent Account Number) allotted by the Income Tax Department. Copy of the same shall be enclosed.
- iii. The bidder should be registered under GST law. Proof of the same (GST registration certificate) shall be enclosed.
- iv. The turnover of the bidder for the past 3 years (i.e. 2017-18, 2018-19 & 2019-20) should not be less than 50 lakhs per annum. CA certificate in respect of the same shall be enclosed.
- v. There should be no legal suit/ criminal case pending or contemplated or legal notice having been served to this effect against the Proprietor of the bidding agency or any of its Directors (in case of Pvt. Ltd. Company) or for violation of any of the laws in-force and should not have been black listed by the any Government organization.
- vi. The registered office/branch office of the bidding agency should be located in **Delhi/ NCR**. The proof of the same (RoC or GST registration certificate) shall be enclosed.

2.2 (B) Instructions to the bidder

Submission of Tender

The tender shall be submitted online in two parts, viz., Technical bid and Financial bid. All the pages of bid being submitted must be sequentially numbered by the bidder irrespective of nature of contents of the documents before uploading. The offers submitted by Telegram/ Fax/ email shall not be considered. No correspondence will be entertained in this matter

2.2(C) Technical bid:

The following documents are to be furnished by the bidders along with the Technical Bid as per Annexure-II of the tender documents:

- i. The copy of the work orders issued to the bidder by any Government Organizations/PSUs/Academic Institutions /Reputed Organizations for the supply of air weapons during any of the preceding 3 years (i.e. 2017-18, 2018-19 & 2019-20)
- ii. A copy of the PAN card.
- iii. A copy of the GST registration.
- iv. CA certificate that the turnover of the bidder for the past 3 years (i.e. FY 2017-18, 2018-19 and 2019-20) was not be less than 50 lakhs per annum.
- v. The self-certification as per annexure-III should be enclosed.
- vi. Proof of the registered office/branch office of the bidding agency **in Delhi/ NCR** should be in form of RoC or GST registration certificate.
- vii. Air weapons, pellets and air rifle jacket supplied should meet standards of International Shooting Sports Federation (ISSF). Self-certification of the same should be enclosed.
- viii. Declaration as per annexure-V should be enclosed.

Note- Bidder may claim relaxation in condition of prior turnover and prior experience with respect to Micro and Small Enterprises subject to meeting of quality and technical specifications as per Ministry of Micro, Small & Medium Enterprises Policy Circular no. 1(2)(1)/2016-MA dated 10.03.2016 and copy of MSME registration should be enclosed along with letter for claiming above relaxation.

2.2 (D) Financial bid:

Financial bid is to be submitted as per format given in Annexure-IV (online). Bidder shall not tamper/ modify downloaded financial bid template in any manner. In case, if the same is found to be tampered/ modified in any manner, tender will be completely rejected.

3. Terms and conditions

1. The rate quoted should be in rupees inclusive of all charges & taxes.
2. Detailed specifications with the mention of make and model/ version of each item should be clearly given supported by the illustrated pamphlets wherever possible.
3. The Air weapons, pellets and air rifle jacket should meet standards of International Shooting Sports Federation (ISSF).
4. The bidder has to quote the price for all the items as per enquiry strictly. Incomplete price bid shall not be considered at all for financial evaluation.
5. Losses or damage in transit shall be borne by the bidder and offered prices should be valid at least for six months from the last date of receipt of bids.

6. Supply of the placed order in part shall not be accepted.
7. **Quality:** The quality of the weapons to be delivered according to the present contract shall correspond to the technical conditions and standards/specifications enumerated in this document. An OEM certificate is required at the time of delivery for the same. In case of non-availability of certificate (which clearly states the manufacturing year of all weapons and air weapons should be of manufacture year 2020 or later) delivery will not be accepted.
8. **Inspection at the time of delivery:** The inspection will be carried out a group of officers on behalf of the NACIN. Representative of bidder must be present at the time of delivery and inspection of delivered items. If the representative of bidder is not present at the time of delivery and inspection, delivered items will not be accepted by the buyer. The delivery of the air weapons will be taken only after necessary checks and tests of the same.
9. **Performance Guarantee-** Performance Guarantee/Security Deposit of 5% of total bid value of air weapons and accessories i.e. Air Rifles 4.5mm (.177) caliber, Air Pistols 4.5mm (.177) caliber, Air pellets rifles, Air pellets pistols and Air rifle shooting jackets shall have to be deposited within 20 days of placing order in the form of FDR/ Bank Guarantee from a Nationalized Bank. This shall be valid upto 90 days beyond warranty. Performance Guarantee will be returned without any interest after successfully completion of term of contract period. This amount shall be confiscated in case of refusal or failure to provide services to the satisfaction of the buyer or backing out of the contractual obligation midstream.
10. **Warranty:** The following Warranty will form part of the contract placed on successful Bidder:-
 - (a) The bidder warrants that the goods supplied under this contract conform to technical specifications prescribed and shall perform according to the said Technical Specifications.
 - (b) The bidder shall provide on-site comprehensive warranty for the air weapons supplied under this contract and each component used in the manufacture along with the manufacturer warranty for a minimum period of 12 months from the date of acceptance of weapons and accessories by NACIN after all static tests and check proof firing or date of installation and commissioning whichever is later. Warranty certificate for all the air weapons and accessories i.e. Air Rifles 4.5mm (.177) caliber, Air Pistols 4.5mm (.177) caliber, Air pellets rifles, Air pellets pistols and Air rifle shooting jackets shall be given at the time of supply of the same. Necessary servicing and spare parts will be provided by the bidder during the warranty period free of cost.
 - (c) Any failure in the air weapons or a subsystem thereof should be rectified within a maximum period of 7 days of lodging a complaint. If within the period of warranty, the goods are reported to have failed to perform as per the specifications, the bidder shall replace the same free of charge, maximum within 45 days of notification of such

defect received by the bidder. Spares required for warranty repairs shall be provided free of cost by bidder.

11. **Terms of Payment-** Payment will be made to the supplier on successful delivery of air weapons and accessories i.e. Air Rifles 4.5mm (.177) caliber, Air Pistols 4.5mm (.177) caliber, Air pellets rifles, Air pellets pistols and Air rifle shooting jackets (along with all factory standard accessories and tools) at site as per the supply order placed by NACIN after the requisite quality check. The quality/ make, brand of weapons shall be strictly as per financial quotation. No advance payment shall be released.
12. Complete user, technical and service manuals/documentation and accessories/spare parts catalogue are to be provided along with the supply of the item.
13. Documents of technical evaluation to be uploaded should be in same order as mentioned in Annexure-II, properly referenced along with page numbers and sequentially listed. Documents submitted otherwise are liable to be rejected.
14. Failure to comply with all the terms and conditions mentioned herein would result in the tender being summarily rejected.
15. Conditional bids shall not be accepted.
16. Any cutting and overwriting in the financial bid shall not be accepted.
17. NACIN reserves the right to reject any or all the tenders without assigning any reasons whatsoever.
18. **Penalty clause (i)-** The period of delivery of the air weapons and accessories shall not be more than 60 days from the date of issue of supply order. In case of delay, a penalty @1% of the total amount per month shall be deducted on pro-rata basis for the delayed period and which would not be more than 90 days from the date of order placed after which NACIN reserves the right to cancel the work order and award it to the next bidder. No claim or damages of any sort would be available to the vendor in case the work order is cancelled due to delay as mentioned above. The performance guarantee submitted by the successful bidder shall be forfeited.
- (d) **Penalty clause (ii)-** During the warranty period, the vendor has to repair the air weapons and accessories at NACIN within 7 days of lodging a complaint. If within the period of warranty, the goods are reported to have failed to perform as per the specifications, the bidder has to replace the same free of charge, maximum within 45 days of notification of such defect received by the bidder. In case of further delay, a penalty would be charged @ 1% of cost of item per week on pro-rata basis for delayed period. The penalty may be waived of if competent authority decides so on merit of the reason.

19. **ARBITRATION CLAUSE:** In case of any disputes between the parties viz. National Academy of Customs, Indirect Taxes & Narcotics (NACIN) on one hand and the bidder awarded the tender on the other hand, arising out on account of conditions and other mandatory liabilities as stated in the Contract Agreement, the dispute shall be referred to Pr.DG/DG NACIN, Sector-29, Faridabad. Decision of Pr.DG/DG NACIN shall be binding on both parties.

20. **Evaluation Criteria:** The Technical bids will be scrutinized on the basis of Basic Eligibility Criteria and documentary evidence as specified in the Tender Document. Financial bids will be opened only of the technically qualified bidder. **The L-1 would be decided on the basis of total expenditure on air weapons.**
