Member (Admin.), CBIC has desired that in this era of digital technology and information explosion there is a need for imparting training on 'DIGITAL FORENSICS' to officers of CBIC to improve their forensic skills and learn with new technological tools like Digital forensics, Electronic Evidence Identification, Collection, Preservation and Analysis of Digital Evidence etc.
