**SUPPLEMENTARY RESULT OF ONLINE WRITTEN EXAMINATION OF
CUSTOMS BROKERS LICENSING EXAMINATION - 2025 (ADDITIONAL)
HELD ON 16.12.2025**

National Academy of Customs, Indirect Taxes and Narcotics (NACIN) is authorised to conduct examinations under Regulation 6 of the Customs Brokers Licensing Regulations (CBLR), 2018 (as amended), vide Notification No. 08/2019-Customs (N.T.) dated 06.02.2019.

2. The Online Written Examination for the Additional Customs Brokers Licensing Examination, 2025 was conducted on 16.12.2025 at designated centres across the country. In terms of Regulation 6(2) of the CBLR, 2018 (as amended), the result of the said examination was declared on 29.12.2025, wherein 173 candidates were declared to have qualified.

3. Subsequent to declaration of the result, representations were received from candidates regarding ambiguity in Question ID-1 and Question ID-118. Upon detailed scrutiny, the Competent Authority observed that ambiguity was indeed apparent in the said questions. Accordingly, full marks (03 marks each) for Question ID-1 and Question ID-118 have been awarded to all candidates who appeared in the examination, irrespective of whether the said questions were attempted or not.

4. Representations relating to Question ID-73, Question ID-49, Question ID-58, Question ID-77 and Question ID-139 were also examined. These questions were found to be correct as per the approved answer key. Accordingly, no additional marks have been awarded in respect of the said questions.

5. Consequent upon the above review, and in accordance with the approved procedure, an additional **18 (eighteen) candidates** have been found to have qualified the written examination. The list of such additional qualified candidates, along with their revised marks, is given below:
