EXAMINATION NOTICE

Subject: Confirmation Examination of (a) Upper Divisional Clerk (UDC) of Central Bureau of Narcotics for the year 2026-27 and (b) Lower Divisional Clerk (LDC) of Central Bureau of Narcotics for the year 2026-27

[Ref.: The Departmental Examination (Central Tax, Central Excise, Customs and Narcotics) Rules, 2024]

- The departmental examination for confirmation of officers in the grade of UDC and LDC of the Central Bureau of Narcotics for the year 2025-26 as mentioned above will be conducted in "Pen and Paper mode" from **14th & 15th, May, 2026** at Central Bureau of Narcotics (HQ), Gwalior, Madhya Pradesh.
- The papers and schedule for the said examination are as below:-

Note: For detailed syllabus, the Departmental Examination Rules, 2024 as notified by the Ministry of Finance, CBIC vide Gazetted Notification dated 18.12.2024 may be referred to (pages- 84-86)

- The question paper shall be set in both English and Hindi medium (except for Paper-II: Hindi). Candidates shall have the option to write the answers either in English or Hindi.
- The concerned Department/Commissionerate/Directorate (Central Bureau of Narcotics) where the examination is scheduled to be held shall nominate an officer (ADC/JC/DC/AC or equivalent rank officer) who will function as the overall in-charge for conduct of the said examination. The details of the authorized officer along with the requisition for the question papers as per Annexure-A (enclosed) should be sent to the Deputy Director (Exam) or the Additional Assistant Director (Exam), NACIN, Shillong through email to the email address: [**nacin.shillong@gov.in**](mailto:nacin.shillong@gov.in)

5. Requisition for question papers along with details of the authorized officer in-charge, duly approved by the competent authority, must reach the Deputy Director (Exam) or the Additional Assistant Director (Exam), NACIN, Shillong **through e-mail only latest by 1st May 2026. It may please be noted that the requisitions received thereafter shall not be entertained.**
6. While informing the requirement, the name of the post and the Roll nos. of the candidate for which the examination is to be conducted may clearly be stated. The Roll nos. of the candidates may be assigned in the order prefixing the "Name of Station" and "Post" for which they intend to appear. E.g. GWALIOR/UDC/01. Any other format of assigning Roll nos. may please be avoided.
7. Candidates working on Deputation/loan basis who are eligible and willing to appear for the examination shall be nominated from their Parent Commissionerate. Such nomination may be sent along with "No Objection Certificate" from the Cadre Control Authority in case the candidate has represented to take up the exam in his/her current place of posting.
8. Question paper for the said exam in password protected PDF format shall be sent to the nominated authorized officer **on 12.05.2026 through e-mail only** who in turn shall acknowledge the receipt of the same to NACIN, Shillong by return e-mail on the same day. **Password for opening the PDF file will be provided on 14.05.2026 one hour before the start of the exam.** The authorized officer shall ensure that the examination is conducted in a fair and transparent manner.
9. The examination notice is also being posted on CBIC and NACIN websites i.e. www.cbic.gov.in and www.nacin.gov.in respectively.
10. A list of eligible candidates appearing for the forthcoming "*Confirmation Examination of Upper Divisional Clerk (UDC) and Lower Divisional Clerk (LDC) of Central Bureau of Narcotics for the year 2026-27*" submitted by Central Bureau of Narcotic, (HQ), Gwalior, (MP) is attached in Annexure – A and Annexure – B herewith.
11. The marks obtained in the examination shall be communicated to the concerned CCAs through email only. Hence, it should be ensured that the correct details of CCA are entered in **Annexure-A** attached with this notice.
12. NACIN, Shillong reserves the right to cancel the whole examination or the examination of a candidate or that of a center or a cluster of centers, if it is found that unfair means were used or allowed to be used or any partiality or injustice is done to anybody during the conduct of the examination. The authorized officer or invigilator of the examination centers also has the right to cancel the examination of a candidate or the whole center under his jurisdiction with the approval of NACIN, Shillong, in case of use of unfair means.
13. It should be ensured that the candidates are clearly notified in either printed form or by seal using rubber stamp on the front part of the answer sheet that any attempt to disclose their names/identity and any form of indulgence in unfair means during the examination hour or

any behavior that may be considered as cheating by the invigilator/supervisor/NACIN shall render their examination as null and void.

14. Instruction for examination is enclosed with this examination notice and is an integral part of it.

15. This issues with the approval of the Additional Director General, NACIN, Shillong.
