हवलदार एवं बहु-कार्यकारी कर्मचारी (एमटीएस) से अवर श्रेणी लिपिक (एलडीसी) के पद पर पदोन्नति हेतु विभागीय परीक्षा, वर्ष 2025-26, दिनांक 16.06.2025 को आयोजित की गई थी।

The Departmental Examination for promotion of Hawaldar and Multi-Tasking Staff (MTS) to the grade of Lower Division Clerk (LDC) for the year 2025-26 was conducted on 16.06.2025.

इस कार्यालय के पत्र दिनांक 06.02.2026 के माध्यम से उक्त परीक्षा में सम्मिलित सभी अभ्यर्थियों का पेपर-I (सामान्य अंग्रेजी), पेपर-II (संख्यात्मक योग्यता एवं सामान्य ज्ञान) तथा पेपर-III (हिंदी) का अंक-विवरण पत्रक सभी संवर्ग नियंत्रण प्राधिकरणों को प्रेषित किया गया था।

Vide this office letter dated 06.02.2026, the Statement of Marks of Paper-I (General English), Paper-II (Numerical Aptitude & General Knowledge) and Paper-III (Hindi) of all candidates who appeared in the aforesaid examination was forwarded to all Cadre Controlling Authorities.

उक्त अंक-विवरण पत्रक में कतिपय अभ्यर्थियों के अंक स्तंभ में "Declaration of Marks put on hold (Identity Disclosure Case)" अंकित किया गया था तथा यह उल्लेख किया गया था कि संबंधित संवर्ग नियंत्रण प्राधिकरणों से उत्तर प्राप्त होने के पश्चात इन अभ्यर्थियों के अंकों के संबंध में उचित निर्णय लिया जाएगा।

In the said Statement of Marks, against the marks column of certain candidates, the remark "Declaration of Marks put on hold (Identity Disclosure Case)" was recorded, with a note that an appropriate decision regarding the declaration of marks of these candidates would be taken after receipt of replies from the concerned Cadre Controlling Authorities.

पहचान प्रकटीकरण प्रकरण एवं अंतिम निर्णय / Identity Disclosure Cases and Final Decision

उत्तर पुस्तिकाओं की विस्तृत जांच के दौरान यह पाया गया कि 34 संवर्ग नियंत्रण प्राधिकरणों/क्षेत्रों/आयुक्तालयों/निदेशालयों के अभ्यर्थियों ने उत्तर पुस्तिकाओं में पहचान प्रकट की थी, जो दिनांक 09.05.2025 की परीक्षा सूचना में "परीक्षा के लिए निर्देश" के अनुच्छेद 5 का उल्लंघन था। इन प्राधिकरणों से स्पष्टीकरण एवं तथ्यात्मक रिपोर्ट मांगी गई और सभी से उत्तर प्राप्त हुए।

During detailed scrutiny of answer sheets, it was found that candidates belonging to 34 Cadre Controlling Authorities/Zones/Commissionerates/Directorates had disclosed their identity in the answer sheets, in violation of Para 5 of the "Instructions for Examination" contained in the Examination Notice dated 09.05.2025. Clarifications and factual reports were sought from all these authorities and replies were duly received from all.

सभी उत्तरों एवं तथ्यों पर सम्यक विचार करने के उपरांत, सक्षम प्राधिकारी ने दिनांक 14.07.2026 को यह निर्णय लिया कि परीक्षा सूचना के अनुच्छेद 5 के प्रावधानों के अनुसरण में, जिन अभ्यर्थियों की उत्तर पुस्तिकाओं में पहचान प्रकटीकरण की विसंगति पाई गई है, उनकी संबंधित पेपर/पेपरों की परीक्षा निरस्त की जाए।

After due consideration of all the replies and facts, the Competent Authority vide approval dated 14.07.2026 decided that in terms of Para 5 of the Examination Notice, the examination of those candidates in whose answer sheets identity disclosure discrepancy was observed, shall stand cancelled in respect of the concerned paper(s).

यह स्पष्ट किया जाता है कि उपर्युक्त निर्णय से संपूर्ण परीक्षा रद्द नहीं हुई है। केवल उन अभ्यर्थियों की परीक्षा, जिनकी उत्तर पुस्तिकाओं में पहचान प्रकटीकरण पाया गया, उन विशिष्ट पेपर/पेपरों के संदर्भ में ही निरस्त की गई है।

It is clarified that the aforesaid decision does not amount to cancellation of the entire examination. Only the examination of those specific candidates who disclosed their identity stands cancelled in respect of the specific paper(s) concerned.

The Statement of Marks covers a total of 110 candidates belonging to 34 Commissionerates/Directorates/Zones where identity disclosure discrepancy was observed.

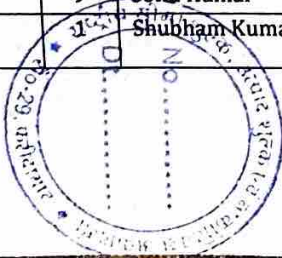

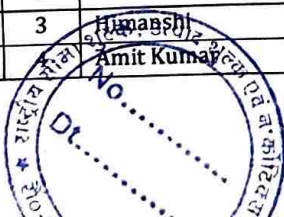

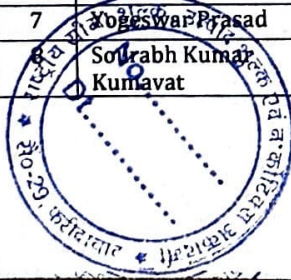
