

## **Terms and Conditions**

- 1. Participating vendors are requested to verify the physical measurement before submitting the tender.
- 2. The price quoted should be inclusive of all the Taxes of Government/Local Authorities etc., as applicable to the Government Department. No payment over and above the prices quoted in the tender shall be made by the department in respect of any such levies brought to the notice at later date.
- 3. Vendors should inspect the venue before submitting the quotations. In case of any query or clarification, they may contact the Assistant Director (Admin.) NACIN, ZC Kolkata on any working day.
- 4. The concerned parties/firms should also enclose copies of documents/certificates evidencing their experience in this field of work along with the sealed tender/quotation (Copies of previous work experience certificate to be submitted).
- 5. The service provider shall complete the required work within a time frame of 10 days. This office retains the right to summarily reject the quotation/order, if the required work is not completed within the stipulated period. No escalation of cost will be entertained in any case in future.
- 6. The work shall constitute of labour all the essential ingredients which will be borne
- 7. The contract would be preferably awarded to the vendor who has quoted the lowest rate while meeting at the terms and conditions given in the tender. However,

- to safeguard against the failure by this vendor while providing the services as per terms and conditions of the tender, the authority reserves the right to empanel other tenderer who are prepared to provide the services on the same terms and conditions as that of L1 tenderer.
- 8. The contractor shall comply with all the applicable laws of the central and state governments and any other law for the time being in force including the GST law. This authority will not be responsible for any dispute that may arise in connection with the subject service, between the vendor and any state or concerned govt dept. e.g authorities dealing with EPF, ESI labour laws, service tax and income tax etc. or any local body.
- 9. The contractor shall identify and keep this office identified against all acts of omission, negligence, dishonesty or misconduct of the personnel or third party including the statutory obligations. For the entire work, the contractor will be the employer for the disputes of his employees.
- 10. The contractor should submit complete rates/quotations only after satisfying each and every condition laid down in the annexure enclosed.
- 11. Bid should be signed by the authorized person and his full name, designation, contact no should be indicated below his signature. GSTIN should be provided in the quotation.
- 12. The contractor should satisfy themselves before submitting of the rate/quotation that they should meet the qualifying criteria as laid down in the Annexure.
- 13. The contractor shall take all possible precautions to prevent any lawful/ disorderly conduct or acts of the employees deployed.
- 14. The contractor shall be fully responsible for theft, burglary, fire or any mischievous deeds by his deployed employees.
- 15. The person(s) so deployed should be employee(s) of the contractor and shall remain under his control and supervision. He shall be liable for the wages and any other claim of the person engaged. The department is not liable to pay any compensation if any untoward incident happens.
- 16. Payment will be made by e-payment directly into the bank account of the vendor on successful completion of work and submission of beneficiary certificate.
- 17. The tenders/quotation which are received incomplete and/or filed after due date shall be summarily rejected.
- 18. Any defect pertaining to construction or use of poor-quality material within a period of three years after completion of the project will be liability of the contractor and he has to repair it free of cost.
- 19. Intending contractor/ bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access of the site, the accommodation they may require and in general shall themselves obtain all necessary information regarding risk, contingencies and their circumstances which may influence or affect their tender. A bidder shall be deemed to have full knowledge of the site whether he inspects it or nor and no extra charge consequent upon any misunderstanding or otherwise shall be allowed.
- 20. The contractor/bidder shall be responsible for arranging and maintaining at his own

cost all materials, tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents and has made himself aware of the scope and specifications of the work to be done and local condition and rates at which stores, tools and plants etc and other factors having a bearing on the execution of the work. Cost of site visit shall be borne by the bidder.
