## **CIRCULAR**

To,

All Zones of Central GST/ Customs/ Directorates under CBIC

Madam/Sir,

Sub: Circular for posting on Loan Basis - Willingness for the post of Inspector at NACIN, Zonal Campus, Mumbai-Reg.

Applications of willing officers are invited to fill up the following posts on loan basis at NACIN, Zonal Campus, Mumbai. Applications are sought from the officers holding analogous posts in the formations of Customs, CGST & Central Excise and officers holding analogous posts in the various Directorates under CBIC in the same pay scale.

- Officer/s selected on loan basis for a tenure of 2 years initially, which can be extended at the discretion of the Competent Authority subject to policies existing in force. The officers selected on loan basis will continue to draw their salary and other allowances from their parent organization, as per applicable Rules and Training Allowance (24% of Basic Pay).
- It is requested that this Circular may please be brought to the notice of all officers working under your jurisdiction. Officers who are desirous of being considered for the above loan basis are requested to submit their applications along with "No Objection Certificate" from the Cadre Controlling Authority (CCA) through proper channel within 30 days from issue of this Circular. Advance copies of the applications, without NOC from the Zonal CCAs, will not be considered. It may be noted that the final selection/appointment is subject to the internal selection process of NACIN, Mumbai and clearance from the respective Cadre Controlling Authority.
- 4. The selected candidate(s) will have to make his/her own arrangement for residential accommodation.
- It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their name on any ground and will also not be relieved till the expiry of the tenure. Needless to say, if the performance and/or conduct of the officer is not found to be satisfactory during his/her tenure at NACIN, the said officer will be repatriated to the parent Commissionerate/Directorate even before completion of the

deputation/loan period.

6. It is requested that this letter may be widely circulated among the officers working in your jurisdiction.
