INTRODUCTION:

The National Academy of Customs, Indirect Taxes and Narcotics (NACIN) is a premier training institute under Central Board of Indirect Taxes (CBIC), Ministry of Finance, Government of India. Established in 1955, Nacin has been playing a pivotal role in training and capacity building of officers of the Indian Revenue Service (Customs and Indirect Taxes); other officers from CBIC cadres and other Allied Services. The academy is also responsible for developing policies, procedures and guidelines related to customs, indirect taxes and narcotics.

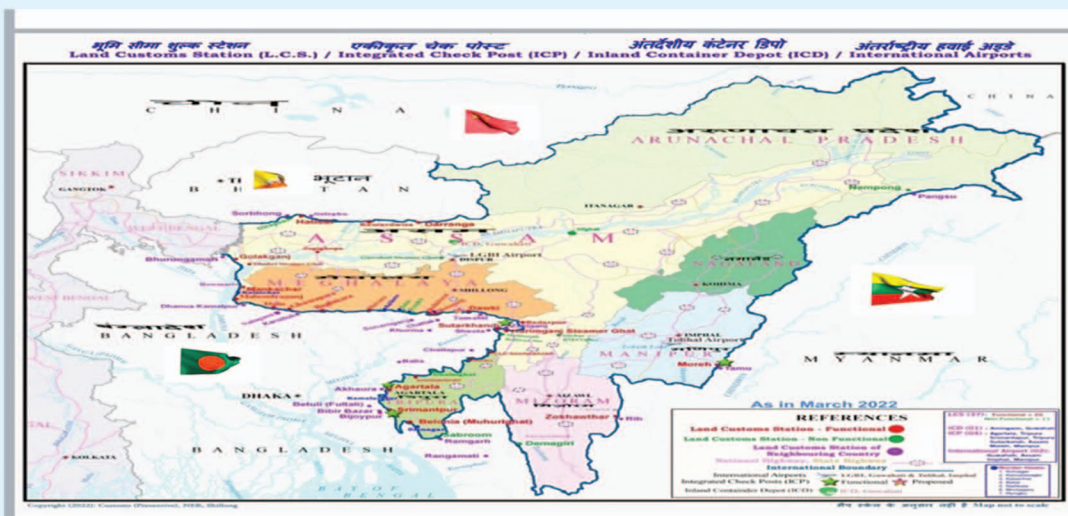
The headquarter of NACIN was recently shifted from Faridabad, to the state of the art new campus at Palasamudram, Goranthla Mandal, Hindupur Taluka, Sri Sathya Sai district of Andhra Pradesh. The campus is equipped with the latest developments in information technology incorporated into the project right from its inception. The national-level institute will train officials of the Indian Revenue Service (Customs and Indirect Taxes) as well as central allied services, state and partner nations, with special focus on use of new-age technologies such as Augmented & Virtual Reality, Blockchain and Artificial Intelligence for training and capacity building.

In addition to the main campus at Palasamudram, Andhra Pradesh & Faridabad, NACIN also operates from 18 other locations known as Zonal Training Institutes(ZTIs) located at Bengaluru, Bhopal, Chennai, Cochin, Delhi, Hyderabad, Kanpur, Kolkota, Mumbai, Patna, Shillong, Chandigarh, Jaipur, Visakhapatnam, Bhubaneshwar, Vadodara and Regional Training Institutes (RTIs) at Raipur and Ranchi.

NACIN, Shillong

Nestled in the picturesque state of Meghalaya lies the largest hill station of India. It is in the heart of Shillong, the capital of Meghalaya where the Office of the National Academy of Customs, Indirect Taxes and Narcotics (NACIN), ZC is located. The Cadre Restructuring 2014 has considered sanction of a Zonal Training Institute for the first time in Guwahati Zone covering the entire North Eastern Region having a geographical jurisdiction of 2,55,168 sq. km comprising of seven states- Assam, Arunachal Pradesh, Meghalaya, Manipur, Mizoram, Nagaland and Tripura.

In the month of September 2017, this Academy relocated from the Hqrs Customs, NER, Shillong premises to a rented building comprising of 2 floors with a floor space of 8832 Sqft owned by the Meghalaya State Housing Financing Cooperative Society Limited, located in Nongrim Hills, Shillong-793003.

Since the month of January 2019, this Academy rented building for Hostel comprising one floor with floor space of 2709 sq. ft owned by the Meghalaya State Housing Financing Cooperative Society Limited, which is located at the same campus in Nongrim Hills, Shillong-793003. The hostel comprises 5 rooms with 19 beds, out of 5 rooms one room with 4 beds is exclusively reserved for female trainees.

MANDATE OF NACIN, ZTI, SHILLONG

The mandate of this Academy is to impart training to officers of all Central GST and State GST formations, covering the jurisdictional area of the entire NE India. The Core Competency areas of this Academy are 'Border trade with Nepal, Bhutan and Bangladesh' and 'Prevention of Wildlife Trafficking/Smuggling, Smuggling of Narcotics, Arms & Ammunition through Indo-Nepal, Indo-Bhutan Border'. The Academy is also taking initiative in sensitizing and building capacity of trade and other stakeholders of North East Region. Induction training for Inspectors and Tax Assistant as well as Mandatory Training for Inspector, Executive Assistants, LDCs & Head Havaldar etc., are conducted in a regular manner as and when required from CCO, Guwahati Zone. Apart from these long trainings, Workshop, Seminar and Training has been conducted for GST Audit, GST Investigation, Refreshers Course for Customs and GST, other Allied Acts, Soft Skills etc.

Specialised training for officers of all level is also conducted in collaboration with Indian Institute of Management, Shillong, North Eastern Police Academy (NEPA), Umroi, and Police Training School, Umran. This Academy is also having a good co-ordination with Regional Training Institute, Indian Audit & Accounts Department Shillong, North Eastern Hills University, Shillong and other Colleges and Institution located at Shillong.
