**Sub: Constitution of the Internal Complaints Committee under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 – Reg.**

In pursuance of the provisions under Section 4(1) of The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, an Internal Complaints Committee is hereby constituted with the following members.

1. <b>Ms. Muskan Khurana</b> , Assistant Commissioner Visakhapatnam North Division, Visakhapatnam CGST Commissionerate	Presiding Officer
2. <b>Smt. Cherukuri Sunitha</b> , President Aasaraa Charitable Society, Visakhapatnam	Member
3. <b>Shri KRS Shankar</b> , Assistant Director	Member
4. <b>Shri A Srikanth Reddy</b> , Additional Assistant Director	Member
5. <b>Ms. Neha Yadav</b> , Inspector	Member

2. The Committee shall deal with any complaints of sexual harassment made by women in the workplace and shall discharge the functions of the Committee specified in the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and the rules made thereunder.

3. As per the provisions of Section 9 of the Act, ibid, inter-alia any aggrieved woman may make, in writing a complaint of sexual harassment at workplace to the Internal Complaints Committee within a period of three months from the date of incident and in case of series of incidents, within a period of three months from the date of last incident.

4. The committee shall prepare in each calendar year a report in terms of Section 21 of The Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013 read with rules made thereunder and submit the same to the Additional Director General, NACIN, Zonal Campus, Visakhapatnam.
5. The members of the Committee shall hold office until further orders.
6. This issues with the approval of the Additional Director General.
