Applications are invited from willing Officers to fill up the following vacant posts on deputation basis in National Academy of Customs, Indirect Taxes & Narcotics, (NACIN), Zonal Unit, Chennai,

These posts are to be filled up from amongst the officers / staff of similar rank working in Customs, GST and Central Excise formations and officers holding analogous posts in the Directorates under CBIC in the same pay scale. The age of the officer / staff should not exceed 56 years as on closing date of this circular.
- 3. Officers/staff selected for a posting in the NACIN, Chennai on deputation basis would normally be appointed for a period of Three (3) Years, extendable up to Five (5) years. It may also be brought to the notice of the willing officers that once selected, they will not be allowed to withdraw their candidature and also will not be relieved till the expiry of three years tenure. While working in NACIN, Zonal unit, Chennai in case if the conduct and work of the officer/staff is not found satisfactory, they shall be reverted to the parent Commissionerate / Directorate prematurely without assigning any reasons.
