5. It may kindly be ensured that once nominated, the officer reports at NACIN, Faridabad for attending to the training course, as last minute cancellation/withdrawal results in considerable administrative and financial issues.

6. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in NACIN campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 650/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner and Rs. 250/- for lunch and tea/snacks, twice a day during the training, which is to be paid separately at the time of registration.
