It is, therefore, requested that suitable Group 'A' and Group 'B' Officers of CBIC may be nominated for 2. participating in the said training.

The telephone/mobile numbers, e-mail address (in capital letters) and Employee ID of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication and for creation of training data base of CBIC officers.

It is, further, requested that hard copy of nomination may not be sent separately through courier or by post so 4. as to avoid wastage of paper.

It may kindly be ensured that the officer once nominated should attend the training course, as last minute 5. cancellation/withdrawal results in considerable administrative inconvenience and financial loss to the Academy. In case of withdrawal due to exigencies, name of an alternative officer may kindly be forwarded to this Academy.

Participants are required to pay Rs. 250/- per day for lunch and tea/snacks (twice a day) at the time of 6. registration.

It is advised that the participants should stay in a nearby Hotel in Faridabad so as to reach NACIN on time to attend 7. the training. Details of a few hotels for ready reference of the participants is attached herewith.

It is incumbent upon the officers from the field formations to display an exemplary behavior during the course of 8. the programme. Any act of indiscipline, such as reporting late for class, use of mobile phone in class, absenteeism etc. shall be viewed seriously and its remedial action could include, inter-alia, reporting the incident to the Zonal Chief Commissioner and recovery of cost incurred on the training.

Participants who report to the Academy after commencement of the first session shall not be awarded certificate 9. of completion.

The nominated officers may please be directed to report to the Academy at Sector 29, Near Police Lines, 10. Faridabad on 28.02.2020 at 9.30 A.M. positively for attending the training. Nearest Metro Station is Sector-28 on the Violet Line. As the valedictory function on 28.02.2020 may conclude around 6.00 P.M., the officers are advised to plan their return journey accordingly.
